On 08/10/09 at approximately 2150 hours I was in the parking lot of Twin Peaks and was flagged down by a male who was operating a white Toyota truck. The male, later identified as Brian Wells informed me that he is a police officer for the city of Manor, TX and on this date he observed some subjects taking a weapon out of a trunk of a vehicle in full view of the public. He pointed out the subjects who committed this and I made contact with them.

The group that Wells directed me towards were subjects who were standing near police cars that said "Criminal Interdiction Unit" and the other car had a light bar on the top of the roof. After identifying myself I asked the subjects who had the most seniority of the group because there was five people. I was informed that the person with the most seniority as Christopher Evans with a date of birth of [REDACTED] I asked to speak to him in private away from the others.

While I was speaking with Evans another person, later identified as Ron Wright with a date of birth of [REDACTED] came over to me. I informed both of them that their group was observed displaying a firearm in play view. Evans and Wright both did not deny it, however, they did not tell me which person did this.

I later spoke to Wells who informed me that the people, who he believed to be police officers, gave a waitress the weapon. Wells was with three other peace officer who worked for different agencies in the surrounding areas. They all observed the group that Wright and Evans was with taking pictures of a waitress on the back of the police cars holding an AR-15 assault rifle.

This location is a licensed premise that sells alcoholic beverage and Wright and Evans did not admit to consuming any alcoholic beverages, however, the other people that were with them had. During this investigation, Detective Rowe was on scene and was able to obtain a phone number for the agency in which they worked for. Prior to leaving the scene, their superiors were notified of the incident along with the command staff for the Round Rock Police Department.

On Monday, August 10, 2009, at about 9:50 PM, I responded to the Twin Peaks Restaurant in reference to a subject with a gun report. Information provided by the caller advised that several males, who appeared to be off-duty Midland County Sheriff's Deputies, were observed walking in the parking lot to two marked Midland S.O. units with a Twin Peaks waitress. The males removed an AR-15 from the trunk of one of the units and allowed the waitress to sit on the trunk of the unit while holding the AR-15. Photographs were then taken of the waitress.

Upon my arrival, several RRPD units had already arrived and were speaking with five males, all found to be full-time Midland County Sheriff's deputies. Officer Shultz and Officer Cole were speaking with two of the males, Christopher Evans (DOB [REDACTED]) and Ronald White (DOB [REDACTED]). I asked who decided to provide an automatic weapon to the waitress. Wright stated that he was involved. I asked what they believed would be a suitable response for their actions. Evans and Wright stated that they would hope for some form of professional courtesy. I advised them that their request was inappropriate. Evans and Wright advised that the waitress asked to have her picture taken with their weapon, but acknowledged they should not have agreed. I then asked them to consider what their response would be to a similar situation in Midland County and both Evans and Wright acknowledged that their actions were unacceptable.

I then spoke with Officer Gogolewski, who was speaking with the remaining three deputies, Miguel Ramos (DOB [REDACTED]), Arturo Nunez Jr (DOB [REDACTED]) and Daniel Suvia (DOB [REDACTED]). According to Officer Gogolewski, Suvia was having difficulty remembering who actually handed the weapon to the waitress. I then approached the three and asked about who retrieved the weapon, Suvia stated that he and Wright removed the weapon and handed it to the waitress. All three acknowledged that they should have never allowed this event to occur.

I then contacted the Midland County Sheriff's office (432-688-4600 and 432-688-4640) and asked to speak with the on-duty supervisor. Suvia then presented me with his cell phone and advised that he had his captain on the phone. I spoke with a male who advised he was Captain McKitrick (unsure of the actual pronunciation). I advised the captain of the events. The captain did not have a pen to write down my contact phone number but asked for my name and stated that he was going to speak with the sheriff and might need something in writing from me. He asked for my name and stated he would call the PD if he needed anything in writing. While I was on the phone with the captain, the on-duty supervisor called me. I returned the call and advised the dispatcher that I spoke with a male who said he was the captain. I was then told that Patrol does not have a captain, Patrol is commanded by a lieutenant. I then asked to speak with the Patrol Lieutenant. I then spoke with the Patrol Commander, Lt. Earl Stroup. I advised Lt. Stroup of the events and he appeared extremely concerned about his deputy's actions. Lt. Stroup effectively communicated that his deputies' actions were not in holding with his department's standards and he would be dealing with this situation upon their return. I then asked about a Captain McKitrick. Lt. Stroup advised that they do have a Captain McKitrick, but he is the Operations Captain and the deputies we were dealing with worked in the Patrol Division and were under Lt. Stroup's supervision.

Officer Gogolewski asked about the camera used to take the photographs. Wright presented the Midland S.O. issued digital camera to Officer Gogolewski and turned it on to display the photo of the waitress, sitting on the trunk of the marked Midland S.O. unit and holding a Midland S.O. issued AR-15 weapon. As the camera possessed potential evidence of the Disorderly Conduct, as reported, I believed it had evidentiary value in this case. I contacted the on-call

D.A. and confirmed that the camera could be seized as evidence. ADA Michael Jarrett believed that since Wright provided the camera and turned it on to display the photo, we could seize the camera, but may need a search warrant to retrieve the image from the camera. I advised Officer Gogolewski of this information.

Statements were obtained by the four witnesses who were off-duty law enforcement officers (one Manor police officer, two Williamson County deputies and one Travis County deputy constable) as well as the waitress. The waitress reportedly stated that the Midland deputies asked her to go outside to take pictures of her holding the weapon on their marked unit.
